1.) Number one tip for submitting a strong application?

No one is a better expert on your lived experiences than you. Know the story you wish to tell and tell it with confidence and authenticity. Showing a willingness to learn from setbacks and demonstrating a mature selfawareness in your own words is key to a successful law school application.

Admission Committees are always seeking candidates who exhibit candor and honesty about their motivations and hopes for the future. Be open to sharing both your perceived strengths as well as weaknesses. This openness can go a long way in exhibiting your maturity and readiness to take on the considerable demands of law school.

Take some time to reflect on the effort and sacrifices that will be necessary to get through law school. The investment you will make in law school is considerable, but the rewards can be truly gratifying and life-changing!
